DIRECTIONS FOR USE: Shake well before use. Hold can 6 to 8 inches from surface to be treated. Spray directly onto surface or dust cloth or mitt. Wipe surface immediately. For extra brilliance, use dry cloth to polish to a beautiful shine.

DANGER: Contains gas under pressure; may explode if heated. Causes eye irritation. May be fatal if swallowed and enters airways. May cause an allergic skin reaction

Keep away from heat, sparks, open flames, and hot surfaces. –No smoking. Pressurized container: Do not pierce or burn, even after use. Protect from sunlight. Do not expose to temperatures exceeding 50°C/122°F. Store in a well-ventilated place. Avoid breathing fumes, mist, vapors, and spray. Contaminated work clothing must not be allowed out of the workplace. Wear protective gloves and eye protection. Wash hands and contaminated clothing thoroughly after handling. If in eyes: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. If eye irritation persists: Get medical attention. If on skin: Wash with plenty of water. If skin irritation or rash occurs: Get medical advice or attention. If swallowed: Immediately call a poison center or doctor. Do NOT induce vomiting. Store locked up. Dispose of contents and container in accordance with local, state, and national regulations.
