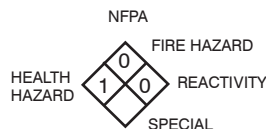
DIRECTIONS: GENERAL APPLICATION: May be diluted with up to 10 parts water. Wipe, mop, spray or mist the area until the malodor has disappeared. Spray air with a mist or pump type sprayer 5 to 10 seconds for each 1500 cubic feet of space. Apply to surfaces to be deodorized until thoroughly wet. Allow liquid to remain on surface whenever possible. Do not rinse. Repeat treatment as necessary. For mopwater, dilute 1:10. STOCKYARDS: Dilute with 10 parts water. Spray onto ground and other areas where odors emanate from. Initial treatment should be twice daily until odor is under control. Thereafter, every other day should be sufficient. In diluted form this product will not harm livestock. SEWER PLANTS: Allow product to drop into waste water at a rate of three drops every five seconds. If odor still persists, after four hours, increase dosage to 6 drops every 2 seconds. After odor is under control, reduce treatment to 2 drops every 8 seconds. For eliminating odors surrounding plant, dilute product with 10 parts water and spray concrete walls above waterline, walkways, ramps, and ground.

WARNING: Causes eye irritation.

Wash hands thoroughly after handling. If in eyes: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. If eye irritation persists: Get medical attention.
