VS 102 kills a broad spectrum of insects on contact. Also contains esfenvalerate for residual treatment up to 7 weeks. Provides total control of listed crawling insects. Pleasant vanilla fragrance.

For use by pest control applicators and janitorial maintenance workers to control ants, roaches, carpet beetles, silverfish, mosquitos, crickets, spiders, waterbugs, scorpions, sowbugs, fleas and ticks in and around homes, hotels/motels, warehouses, schools, office buildings, industrial plants, restaurants, and retail outlets.

FIRST AID

ENVIRONMENTAL HAZARDS

PHYSICAL OR CHEMICAL HAZARDS

FLAMMABLE. Keep away from heat, sparks, and open flame. Do not use under or around gas stoves, water heaters, or other gas utilities (including home heating units) with open flames or pilot lights. Contents under pressure. Do not puncture or incinerate container. Exposure to temperatures above 130°F may cause bursting. DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Use Restrictions & Precautions

- Do not allow adults, children, or pets to enter the treated area until vapors, mists, and aerosols have dispersed, sprays have dried and the treated area has been thoroughly ventilated.
- Do not apply this product in a way that will contact adults, children, or pets, either directly or through drift. Only protected handlers may be in the area during application.
- Remove pets, birds and cover fish aquariums before spraying.
- Apply this product only as a coarse spray or crack and crevice treatment to localized areas where pests are found or may occur. Spray surfaces until wet.

- For indoor use, remove or cover exposed food and drinking water before application.
- For indoor use, remove or cover dishes, utensils, food processing equipment, and food preparation surfaces, or wash them before use.
- Do not use in aircraft.
- For indoor residential dwellings and outdoor sites (including outdoor residential sites, automobiles, and manure):
 - *Product must be formulated to deliver no more than this maximum rate when used according to directions:*
 - Surface applications – 0.01 lbs ai/1000 square feet
 - Crack/crevice or spot – 0.05 lbs ai/1000 square feet
- For pet premise treatment (pets are not present):
 - *Product must be formulated to deliver no more than this maximum rate when used according to directions:*
 - Surface applications – 0.01 lbs ai/100 square feet

SHAKE WELL BEFORE USE

Use this spray as a spot or crack and crevice treatment to control cockroaches, fleas, silverfish, ticks, waterbugs, and other insects listed below.

FOR SPOT TREATMENT:

TO KILL **Black Widow Spiders, Carpet Beetles, Cockroaches, Crickets, Scorpions, Silverfish, Sowbugs and Spiders:** Spray areas where these insects are found or may hide, including dark corners of rooms and closets; cracks and crevices in walls; along baseboards and door and window frames; behind and beneath sinks, stoves, refrigerators, and cabinets; and around garbage cans, plumbing and other utility installations. Pests driven out of hiding places should be sprayed directly.

Ants: For ants, spray ant trails and around doors and windows, and wherever else these pests may find entrance.

Brown Dog Ticks and Fleas: Apply as a spot treatment to infested areas such as pet beds and resting quarters, nearby cracks and crevices, along and behind baseboards, window and door frames, and localized areas of floor and floor coverings where these pests may be present. Pet's old bedding should be removed and replaced with clean, fresh bedding after treatment. **DO NOT SPRAY PETS WITH THIS PRODUCT.** Treat pets with a registered flea and tick control product prior to reentering treated areas.

FOR CRACK AND CREVICE TREATMENT:

TO KILL **Ants, Black Widow Spiders, Brown Dog Ticks, Carpet Beetles, Cockroaches, Crickets, Fleas, Scorpions, Silverfish, Sowbugs and Spiders:** Apply spray in small amounts directly into cracks and crevices. Equipment capable of delivering a pin stream should be used in points between different elements of construction, between equipment and floors, openings leading to voids and hollow spaces in walls, equipment legs and bases where these insects hide. Care should be taken to avoid depositing the product onto exposed surfaces or introducing the material into the air. Avoid contamination of food or food handling surfaces.

Flies and mosquitoes: Use only outdoors as an aid in reducing annoyance from these insects. Spray outside surfaces of window and door frames as well as other areas where these pests may enter the home. Also spray dark corners and localized resting areas (such as under eaves) or porches, patios, and garages where these insects may congregate. Flies and mosquitoes coming to rest on treated surfaces will be killed.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage and disposal. **STORAGE:** Store in a cool, dry place. Keep container closed. **DISPOSAL AND CONTAINER HANDLING:** Do not puncture or incinerate! If empty: Place in trash or offer for recycling if available. If partly filled: Call your local solid waste agency or 1-800-CLEANUP for disposal instructions.
