Consists of metal cross linked acrylic polymers and polyethylene. This product can be used as a sealer/wax in most applications.

This product is a high solids, high gloss polymer floor finish. Once applied, it provides exceptional shine and protection to all types of tile and synthetic floors. Prevents black heel and rubber burn marks. Easy to maintain, just mop and allow to dry. Can be buffed if desired. Applies quickly and easily with damp mopping.

DIRECTIONS FOR USE: Strip off old floor finish thoroughly and rinse completely with water. Allow floor to dry. Apply thin even coats at a rate of 2000 square foot per gallon. Allow each coat to dry for 20 minutes before reapplying. Sweep floor and mop daily for best results. May be spray buffed if desired.

CAUTION: Do not take internally. If swallowed give water and contact physician. Keep out of eyes. If in eyes flush thoroughly with water and consult a physician.
